Please note!

Dear Autobid.de Customer,

Please note the following information:

The listed standard equipment is based on the manufacturer's original price list. The actual vehicle specification may differ from the listed standard equipment. We do not provide any warranty or guarantee as to the accuracy or completeness of the listed standard equipment.

Only the published vehicle photos are binding. Usual signs of use and wear not shown in the photos – such as scratches, dents, paint defects, or similar – are deemed to be an agreed condition of the vehicle.

Any vehicle for which a bid has been submitted is subject to confirmation, irrespective of the bid amount. Within 5 business days after the end of the auction, you will be notified whether your bid has been accepted.

Following this auction, vehicles will be transported to the Rhein-Ruhr Auction Centre in Marl and delivered with the following documents:

- **Vehicles from Belgium or Luxembourg** are delivered with Belgian/ Luxembourg registration documents.
- **Dutch vehicles WITH “remaining BPM” (NL registration tax)** are exported and registered in Germany for one day on behalf of Auktion & Markt AG. Delivery takes place with German registration documents including one registered keeper entry. The current Dutch APK (periodical technical inspection) validity date will be adopted. If the APK validity is less than 14 days, the vehicle will receive a new technical inspection prior to the German registration. Both the registration and any required new inspection are included in the sale price.
- **Dutch vehicles WITHOUT “remaining BPM”** will be delivered with exported Dutch registration documents.

COC documents and separate APK/technical inspection certificates are generally not part of the delivery scope.

For vehicles delivered with Dutch registration documents, German registration documents including a keeper entry (incl. required data sheet / type approval documentation) can be arranged upon request against reimbursement of costs. If a new APK/technical inspection is required for this purpose, this can also be organized against reimbursement of costs.

The fees are € 179 for the preparation of German registration documents and € 159 for a potentially required new APK/technical inspection. The preparation of German registration documents is carried out on a best-effort basis and cannot be guaranteed in individual cases. In such cases, the fee will not be charged. Requests must be submitted within 2 working days after the hammer price has been accepted.

Applicable only to buyers from the Netherlands:

Delivery and invoicing are handled by Auktion & Markt AG Netherlands (location Velddriel), including Dutch VAT and, if applicable, remaining BPM. The invoice price will be increased accordingly by these amount. Vehicles with a current Dutch registration will keep their registration, which, after payment, will be made available for transfer into the buyer's RDW dealer stock. The vehicles will be ready for pickup in Velddriel within 5 working days after payment.

By submitting a bid, the bidder agrees to the special conditions stated above.
